# NO FUNDING, NO FUTURE.

As President of Aontas na Mac Léinn in Éirinn (AMLÉ), I am honoured to present our Pre-Budget Submission for the coming year. This document is not just a collection of policy recommendations—it is a reflection of the real, lived experiences of students across Ireland. It is a call to action, urging the government to address the growing challenges that threaten the right to education for thousands of learners.

In recent years, the difficulties facing students have intensified to an unprecedented degree. The severe lack of affordable, safe, and accessible accommodation has left many in a state of constant uncertainty. Students are being forced to choose between continuing their education or securing basic living conditions—an impossible and unjust choice.

The situation is compounded by the rising cost of travel, particularly for students who must commute long distances due to the housing crisis. Public transport remains insufficient, expensive, and, in many areas, entirely unavailable—adding further financial and emotional strain. On top of this, Ireland continues to impose some of the highest third-level tuition fees in the EU, a barrier that excludes many capable students from the opportunities they deserve.

These are not isolated challenges. They are interlinked crises that demand an urgent, coordinated response.

These issues go beyond the individual. They threaten our national ambition for a fair, inclusive, and knowledge-driven society. When we fail to support students, we fail to invest in Ireland's future.

In this submission, AMLÉ calls on the government to act decisively and invest in the following areas:

A major expansion of affordable, purpose-built student accommodation, supported by public investment and regulated to ensure fair rents and quality standards.

A national overhaul of public transport for students, including more extensive routes, lower fares, and greater investment in rural connectivity.

A meaningful reduction in tuition fees, alongside a substantial increase in student financial supports, to ensure equitable access to education for all.

These are not unreasonable demands. They are essential steps toward protecting the right to education, tackling inequality, and unlocking the full potential of Ireland's future workforce and leaders.

Students are ready to contribute to a better, stronger Ireland. But we need the government to meet us with equal commitment. We urge our leaders to recognise the urgency of this moment—and to deliver a Budget that puts students first.

Together, we can ensure that no student is left behind.

# 2026 Pre-Budget Submission

The asks outlined in our Pre Budget Submission represent the views of our members, as laid out by our most recent national congress, Comhdháil, which took place in April 2025.

In our submission, we are calling on the Government to properly invest in third level education. Better supports must be implemented for students learning in Ireland. These supports range from structural, with greater investment into student accommodation, to financial, with reform of the SUSI Grant system being a high priority of ours.

Postgraduate Taught Supports.

Improved financial supports for postgraduate taught students in the form of greater availability of grants and scholarships, and putting in place fee controls and/or caps on postgraduate taught fees, for both EU and non-EU/EEA students.

Postgraduate Researcher Supports.

All PhD researchers to be paid no less than €25.000, in line with the recommendations from the National Review of State Supports for PhD Researchers, with a view to granting PhD researchers fulltime employee status of their respective institutions in order to match stipends to minimum wage.

International Postgraduate Supports (Non-EU/EEA).

Abolishment of the €300 fee for renewal of the Irish Residence Permit (IRP) to be waived by the Department/sponsored by research Bodies.

Similarly, pathways to fund visas, Garda vetting, and other immigration costs should be introduced by research bodies and the Department. **Hosting Agreement Schemes** should be provided to non-EU postgraduate researchers to allow them to avail of a work permit and employment rights.
